NOTICE OF RACE

The notation '[DP]' in a rule means that the penalty for a breach of that rule may, at the discretion of the Protest Committee, be less than a disqualification.

- 0. COVID-19 STATEMENT:** By taking part in any of the events covered by this notice of race, each competitor agrees and acknowledges that they are responsible for complying with any regulations in force from time to time in respect of COVID-19 and for complying with the Draycote Water Sailing Club's COVID-19 procedures.
- 6-10 boats per slipway – adhering to social distancing at all times – please follow site marshals' directions.
 - All sailors to read the site rules available [here](#) (again, subject to change).
 - If results are quick, the winners will be invited to a private prize giving.
 - Results will be posted online.
 - The changing rooms will not be available, please arrive appropriately equipped for this
 - The OA may cancel the event, cancel classes and reject or cancel entries in its absolute discretion, subject to RRS 76. In these cases, refunds will be issued less any costs incurred.

1. RULES

- 1.1. This event is governed by the rules as defined in *the Racing Rules of Sailing 2021-2024*.
- 1.2. Competitors shall sail in accordance with the [RYA Racing Charter](#).
- 1.3. Topper *Class Rules* shall apply as standard
- 1.4. The Sailing Instructions may also change rules, in the event of a conflict the SI's take precedence.
- 1.5. [DP] All Competitors are required to wear personal flotation devices while float, except while briefly adjusting clothing or personal equipment, Flag Y will not be displayed. This changes RRS 40.

2. SAILING INSTRUCTION

- 2.1. The sailing instructions will be available electronically at [website](#).

3. COMMUNICATION

- 3.1. The official notice board will be [online](#).
- 3.2. [DP] While racing, except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4. ELIGIBILITY & ENTRY

- 4.1. The event is open to all boats of the Topper class.
- 4.2. All competitors must be current members of the class association.
- 4.3. Eligible boats may enter by completing the [online registration](#) and paying the required fees by 23:59 on 2nd April 21.
- 4.4. Entries are limited to 60.
- 4.5. [DP] A disclaimer must be verbally agreed to before launching for each visiting boat to state that the Check, Clean, Dry programme has been observed prior to arriving at Draycote Water and will be observed afterwards.
- 4.6. All boats shall sail under their register numbers to comply with RRS 77. Under exceptional circumstances a boat may be permitted to carry sail numbers or letters in contravention of her class rules provided that written application, stating the circumstances, is made to the Race Committee prior to 1st race. If such permission is granted no further change will be permitted.

- 6.1. [DP] Boats maybe required to display advertising chosen and supplied by the organising authority.

9. EQUIPMENT INSPECTIONS

- 9.1. Boats and equipment may be inspected at any time.

10. VENUE

- 10.1. The venue is Draycote Water Sailing Club, Draycote Water, CV23 8AB.
- 10.2. The sailing area will be Draycote Water.

11.COURSES

- 11.1. The course will be Trapezoid.
- 11.2. Full details will be in the sailing instruction.

12.PENALTY SYSTEM

- 12.1. The post-race penalty and RYA arbitration of the RYA Rules Disputes Procedures will be available. The post-race penalty will be 30%.

13.SCORING

- 13.1. One race shall constitute an event
- 13.2. If 3 or fewer races have been completed a boats score shall be the total of her race scores
- 13.3. If more than 3 races have been completed a boats score shall be the total of her race scores excluding her one worst score.

14.SUPPORT VESSELS

- 14.1. Support boats will not be allowed.

15.DATA PROTECTION

- 15.1. Results,

As part of entering this event your results will be published in the public domain and may be given to the RYA for their Portsmouth Yardstick scheme and to the Class Association. While your results contain personal data, it is normal practice to expect that, when entering an event, your results will be published, and this is a condition of entry. It is therefore part of the contract to provide you with race entry and administration that we will publish the results, which may include such information such as sail number, sailing club, age and gender (if there are age and gender related results).
- 15.2. Photography,

By competing in this event, competitors grant to the organisers without payment the right in perpetuity to make, use and show any non-identifiable motion pictures, still pictures and live, taped or filmed television of or relating to the event and consent to these being published in class, club, sponsor and other publications and / or the class, club, sponsor or other websites.

16.RISK STATEMENT

- 16.1. Rule 3 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone."

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk.
- 16.2. By taking part in the event, each competitor agrees and acknowledges that:
 - 16.2.1. They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
 - 16.2.2. They are responsible for the safety of themselves, their crew, their boat and their property whether afloat or ashore;

- 16.2.3. They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- 16.2.4. Their boat is in good order, equipped to sail in the event and they are fit to participate;
- 16.2.5. The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
- 16.2.6. The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
- 16.2.7. It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any competitors briefing held for the event.
- 16.2.8. The organising authority will not accept any liability for loss, material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

17.INSURANCE

- 17.1.Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £3,000,000 per incident or the equivalent.

18.PRIZES

- 18.1.Prizes will be awarded as in 19.2 at prize giving located on the patio asap after the final race of the final day.
