

## 3. Report of the Committee




#### Club Year March 2022 - 23

- Enhanced reputation nationally across fleets
- Now a venue of choice for large events
- Membership income increase but limited
- Changing membership profile
- Fourfold increase in utility costs
- Double digit increase in costs across the board
- Continued investment in equipment, club house & site
- Small Committee continues to shrink
- Development plan provides the framework for continued growth
- Significant Draycote Water Sailing Club members' sailing achievements
- Lifetime Achievement & RYA Volunteer Award 2022/3 Jon Hughes

### A Challenging Year

- As predicted the last 12 months have been tough very tough!
- Significant increase in costs
  - Insurance
  - Utility
  - Wages
- Continued development and investment of the club infrastructure
- Full complement of salaried water side staff for first time in 4 years
- Limited catering staff
- Removed flat tenant due to flat requiring substantial works going forward
- Reduced site capacity due to Severn Trent dam works


## Stubbornly Static Membership Income

#### Submitted Question

- A question about the race format was submitted by Neil Kelsall:
- Question: Sunday race format: whether more back-to-back racing has ever been considered, instead of the current morning and afternoon races?
- Answer:
  - Fleet Captains' Meeting issue: Menagerie fleet not represented
  - Afternoon racing is not as popular as morning (mainly due to ILCA & Aero not having pm in series)
  - Discussed at last Fleet Captains' Meeting & highlighted for further consideration
  - Has been discussed many times & rejected for 3 main reasons:
    - 1. Impossible to maintain number of starts & achieve a sufficiently fast turnaround between the 2 races
  - 2. Many members are on the older side, and some cannot comfortably stay on the water for 2+ hours
  - 3. While some favour a 'time efficient' approach, others enjoy spending the day at the Club sailing and relaxing. But I'm sure the new RCS will be reviewing with the fleet captains (with or without the menagerie fleet's input!)



- Catering offering






#### Commercial and Staff News

- Increased RIB security following engine loss
- Trailer park tidy
  - Scrapped old trailers
- Future developments
  - Continued development of the boat park
  - Replacement club house radiators
  - Painting and decorating
  - RIB, dinghy & board replacement schemes continue
  - Plan for the use of the flat space going forward
  - Post Dam works site changes
  - Prepare for future infrastructure replacement

### Severn Trent Site Development

- Good open working relationship established and being developed with senior management
  - Return of site tenants' meetings
- Car park, visitor centre & fisheries
  - ST plans to build a larger additional car park on our trailer park has been mothballed
  - Public car park potentially ANPR controlled
  - We are requesting a code barrier to protect our car parking
  - Fisheries Lodge moving to unknown solution going forward
  - Further development of visitor centre and or other buildings planned
- Dam works have legal requirement for the siphon to be operational
  - Ongoing plans for collection pond being made
  - On site for another 6-12 months
- Water level rise being proposed
  - 0.6m rise of the high-water mark
  - Impact unknown but DWSC being suggested to be part of the stake holder committee.







#### **Unadjusted Income (£k)**





#### Submitted Question


- Two questions about the accounts submitted by Robin Verso:
- Question: The sailing and admin wages have gone up by nearly 23% to £103,000.
- Answer: This is a result of the return to a full complement of staff for the first time since before covid19. We now have two bosuns on alternative weeks (Mark & Andy) which the regular staff have been covering by working excessive hours. This could not continue.
- Question: Under Finance Costs on Page 14 of the accounts Could you please explain the Credit Card cost of £9,118
- Answer: This is simply the transactional costs incurred from handling electronic payments now we are cashless. There has obviously been an offset in reduced cashing costs as well as unmeasured staff time travelling and counting money.

#### Overall Financial Performance




- Small deficit due to increased costs

# Approval of the 2022 / 2023 Accounts



#### First 6 Months' Income




- Membership income has increased slightly






