# **NOTICE OF RACE**

The notation '[DP]' in a rule means that the penalty for a breach of that rule may, at the discretion of the Protest Committee, be less than a disqualification

#### 1. RULES

- 1.1. This event is governed by the rules as defined in the Racing Rules of Sailing 2021-2024.
- 1.2. Competitors shall sail in accordance with the RYA Racing Charter.
- 1.3. Topper Class Rules shall apply as standard.
- 1.4. [DP] Rule 40.1 applies at all times when afloat.

# 2. SAILING INSTRUCTION

2.1. The sailing instructions will be available electronically **HERE**.

### 3. COMMUNICATION

- 3.1. The official notice board will be online.
- 3.2. [DP] While racing, except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

## 4. ELIGIBITY & ENTRY

- 4.1. The event is open to all boats of the topper class.
- 4.2. All competitors must be current members of the class association.
- 4.3. Eligible boats may enter by completing the <u>online registration</u> and paying the required fees by 8pm on the Thursday 25th<sup>th</sup> April 2024.
- 4.4. Entries are limited to 50 boats
- 4.5. [DP] A disclaimer must be signed before launching for each visiting boat to state that the Check, Clean, Dry programme has been observed prior to arriving at Draycote Water and will be observed afterwards.
- 4.6. All boats shall sail under their register numbers to comply with RRS 77. Under exceptional circumstances a boat may be permitted to carry sail numbers or letters in contravention of her class rules provided that written application, stating the circumstances, is made to the Race Committee prior to 1st race. If such permission is granted no further change will be permitted.

#### 5. FEES

5.1. The entry fee is £20.

#### 6. ADVERTISING

6.1. [DP] Boats maybe required to display advertising chosen and supplied by the organising authority.

#### 9. EQUIPMENT INSPECTIONS

9.1. Boats and equipment may be inspected at any time.

#### 10.VENUE

- 10.1. The venue is Draycote Water Sailing Club, Draycote Water, CV23 8AB.
- 10.2. The sailing area will be Draycote Water.

#### 11.COURSES

- 11.1. The course will be Trapezoid
- 11.2. Full details will be in the sailing instruction.

# **12.PENALTY SYSTEM**

12.1. The post-race penalty and RYA arbitration of the RYA Rules Disputes Procedures will be available. The post-race penalty will be 30%.

## 13.SCORING

- 13.1. One race shall constitute an event
- 13.2. If 3 or fewer races have been completed a boats score shall be the total of her race scores
- 13.3. If more than 3 races have been completed a boats score shall be the total of her race scores excluding her one worst score.

#### **14.SUPPORT VESSELS**

- 14.1. ITCA have arranged for a coach to provide on-water coaching to the less experienced sailors during the races. This is not intended to give individuals unfair advantage, rather to support their development and motivation for the future. No other support teams will be allowed on the water.
- 14.2. Additional support boats will not be allowed.

#### **15.OUTSIDE ASSISTANCE**

15.1. Rescue crews are permitted to assist helms who are struggling to right their boat after a capsize. The crew will stand by until it is apparent that assistance is required and then assist in righting the vessel. Helms may then continue to race as the capsize is viewed as sufficient penalty. The rescue crew will attend and assist in the order that they see the vessels capsize. **This changes RRS 41.** 

#### **16.DATA PROTECTION**

16.1. Results,

As part of entering this event your results will be published in the public domain and may be given to the RYA for their Portsmouth Yardstick scheme and to the Class Association. While your results contain personal data, it is normal practice to expect that, when entering an event, your results will be published, and this is a condition of entry. It is therefore part of the contract to provide you with race entry and administration that we will publish the results, which may include such information such as sail number, sailing club, age and gender (if there are age and gender related results).

#### 16.2. Photography,

By competing in this event, competitors grant to the organisers without payment the right in perpetuity to make, use and show any non-identifiable motion pictures, still pictures and live, taped or filmed television of or relating to the event and consent to these being published in class, club, sponsor and other publications and / or the class, club, sponsor or other websites.

#### **17.RISK STATEMENT**

- 17.1. Rule 3 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone."

  Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk.
- 17.2.By taking part in the event, each competitor agrees and acknowledges that:
  - 17.2.1. They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
  - 17.2.2. They are responsible for the safety of themselves, their crew, their boat and their property whether afloat or ashore;
  - 17.2.3. They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
  - 17.2.4. Their boat is in good order, equipped to sail in the event and they are fit to participate;

- 17.2.5. The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
- 17.2.6. The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
- 17.2.7. It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any competitors briefing held for the event.
- 17.2.8. The organising authority will not accept any liability for loss, material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

#### **18.INSURANCE**

18.1.Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £3,000,000 per incident or the equivalent.

#### 19.PRIZES

19.1.Trophies will be awarded as in 19.2 at prize giving located on the patio asap after the final race of the final day.
